- 一、 依據「教育部補助大專校院及其附設華語文教學機構設置外國學生獎學金 核撥作業規定」,為獎勵優秀外國學生,特設立本辦法。
- 二、 金額:每次每名受獎金額為新臺幣伍萬元整。

三、 經費與名額:

- 本獎學金經費來源包含教育部外國籍學生獎學金補助款及校內預算,每 學年名額視當年度補助款與校內預算額度而定。
- 2. 本獎學金依每學年度第1學期各學院外國學生註冊人數比率分配予各學院相對名額,外國學生註冊人數未達5人之學院則共同以同一比率分配名額。
- 3. 於每學年度第1學期公告當學年度上下學期分配名額。

四、申請資格

- 限具本校正式學籍之外國學生(不含港澳僑陸生、交換學生與雙聯/三聯學制生),就讀本校滿一學期,前學期操行成績80分以上,且達下述規定者:
 - (1) 學士班學生:前一學期修課學分數須符合本校選課辦法訂定標準, 且學業成績平均需達70分以上。
 - (2) 碩博士班學生:前一學期至少修習3學分,且學業成績平均需達75 分以上。
- 2. 上課出席情況正常 (請假、缺曠課時數不得超過總時數 1/5)。
- 3. 持學生身份簽證而非工作簽證者。
- 4. 未獲其他獎助學金。

五、申請文件:

1. 獎學金申請表乙份;

- 2. 中文歷年學業成績單正本乙份(大學部與碩一須含班級排名);
- 3. 教師推薦信乙份;
- 4. 其他證明文件,如參加課外活動證明、參加競賽獲獎證明、發表論文證明 等(無則免附)。

六、申請時間:

本獎學金每年受理申請 2 次,約為 10 月下旬與 3 月下旬,惟實際日期仍以國際教育處公告時間為准,逾期不予受理。

七、獎學金核定:

- 外國學生註冊人數達5人以上之學院,由該學院收件並組織公平客觀之委員會審核學生資格,挑選最優秀學生,並依分配名額推薦優先順序人選。
- 外國學生註冊人數未達5人之學院,由國際教育處國際學生中心統一收件,交由輔仁大學國際學術交流審議委員會進行審查,依分配名額推薦優先順序人選。
- 3. 錄取名單經國際教育處國際學生中心彙整後,簽由國際教育長核定。
- 八、校內單位可安排受獎生進行義務服務,如外國籍學弟妹照顧、學習分享會、 文化講座與校園雙語化等內容。

九、本辦法經行政會議通過,送請校長核定後施行。修正時亦同。

Fu Jen Catholic University International Student Scholarship

- 1. The scholarship aims to encourage outstanding FJU international degree students.
- 2. Amount: Each recipients will be awarded NTD50,000.
- 3. Funding and Number of recipients
 - (1) The scholarship is funded by the Ministry of Education (MOE) and Fu Jen Catholic University (FJU). The number of recipients is subject to change according to the annual budget.
 - (2) The scholarship will be equally distributed to each college according to the ratio of enrollment of international degree students.
 - (3) The quota of each college will be announced in the first semester per academic year.

4. Qualification

- (1) Students who formally enrolled as an international degree student at FJU (not including overseas Chinese students, exchange students or dual/joint degree students) and have studied for over one semester with conduct performance of over 80 points in the previous semester. They should also meet the following requirements:
 - (a) Undergraduate students who take required credits listed in <u>FJU Course</u> <u>Selection Regulation</u> and obtain a grade point average of 70 or above in the previous semester.
 - (b) Graduate students who take at least 3 credits and obtain a grade point average of 75 or above in the previous semester.
- (2) Students who cannot be absent for more than one-fifths in the previous semester.
- (3) Students who hold the ARC with a purpose of studying instead of working.
- (4) Students who do not receive any other scholarship or student-aid.

5. Required Documents

- (1) Application Form
- (2) One original transcript in Chinese with ranking within the class for all semesters
- (3) One recommendation letter
- (4) Other relevant proofs such as participation of voluntary work, extra-curricular activities, award certificate, or publication (It is not a must)

6. Application Time

(1) The scholarship is available every semester and accepts applications around the end of Oct. and Mar. The actual date is entitled to change according to latest announcement. Please note the late application will not be accepted.

7. Scholarship Approval

(1) For those colleges with 5 or more than 5 international degree students, the college should accept applications and organize a committee to evaluate applicants to nominate elite applicants by ranking order according to the distributed quota.

- (2) For those colleges with less than 5 international degree students, International Student Center (ISC) of OIE will accept applications. The applicants will be evaluated by FJU International Academic Exchange Examining Committee to nominate elite applicants by ranking order according to the distributed quota.
- (3) Admission list will be collected by ISC of OIE and then approved by the Dean of OIE.
- 8. The school may arrange voluntary work for recipients, such as peer-learning, experience sharing, cross-cultural seminars or bilingual campus implementing.
- 9. The regulations have been approved by the Administrative Council and the President of FJU. Any amendments shall be processed accordingly.
